Application for 24/7 Webline and eStatement Disclosure Agreement

Webline.

By signing below, I am applying for Sun Center Federal Credit Union's online banking service utilizing the 24/7 Webline. Should the service be approved, I understand that all account agreements, disclosures, and fee schedules will govern my use of Sun Center Federal Credit Union's online banking service. I understand it is my responsibility to secure my password. Since it is to be used for security purposes, I understand if I disclose my password to any non-owner of my account, I will be responsible for all transactions performed on my account. I understand that Sun Center Federal Credit Union may cancel this service at any time.

Electronic Disclosure Agreement.

Accessing your Sun Center Federal Credit Union eStatements confirms your agreement to be bound by all disclosures and agreements, and acknowledges your receipt and understanding of this agreement. By entering this agreement, you understand that Sun Center Federal Credit Union will no longer be providing you with a monthly/quarterly paper statement. Your statements will be available online, and you will be notified through email when your eStatement is available, with a link to the eStatement login page.

Accessing your eStatements.

In order to access your eStatements online, you must establish and maintain an accurate email address. An Internet connection that supports 128-bit encryption is recommended. You must have access to Adobe Acrobat Reader software (available at no charge at <http://www.adobe.com/products/acrobat/readstep2.html>) to access your eStatements, a printer or ability to download the eStatements for your records.

Service Availability.

The service providing eStatements is generally available 24 hours a day, 7 days a week; however, this service may be unavailable from time to time for routine software and hardware maintenance or due to unscheduled down time.

Please read this Agreement carefully before accessing or using the service. By accessing or using the service, you agree to be bound by the terms and conditions below. If you do not accept the terms and conditions of this Agreement, you may not access or use the service. The Credit Union may modify this Agreement from time to time, and such modifications shall be effective immediately upon posting of the modified Agreement. By continuing to access or use the service following such modifications, you agree to be bound by the modified Agreement.

You must not restrict or inhibit any other user from using the service. You may not use the service to send any unlawful, fraudulent, libelous, defamatory, obscene, pornographic, threatening, offensive, or otherwise objectionable information of any kind. You may not use the service to conduct any illegal activity or solicit the performance of any illegal activity, including without limitation the U.S. export control laws and regulations.

Charges.

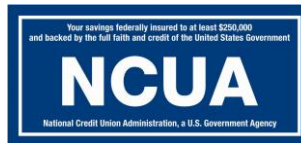
